4. Services

The payment of the participation fee includes the following services:

4.1 Company-specific services

All materials and facilities shall be at the disposal of the exhibitor, on a rental basis, only for the duration of the event, and may in no way be damaged or modified. Damaged or modified components and devices shall be repaired or replaced at the expense of the exhibitor.

Hall space including stand construction

- Provision of stand space (9 m²) in the hall with the stand design bearing "A+A@RISCON". Exhibitors may not obscure elements of the stand design.

 - Back and dividing walls

 - Uniform floor covering on the stand
 - General stand lighting

 - one socket (without distribution/switching panel)
- NB: Costs for additional electricity supply to the stand from the nearest distribution point will be charged to the exhibitor, and will be invoiced on the basis of the kW registered by the exhibitor. Additional light and power current usage have to be paid by the exhibitor.

4.2. General services
